

Provisions Day School Niederbipp

General

The Day School Regulations set out the modalities for the conclusion of childcare agreements between parents/guardians and the Day School Niederbipp. They are based on Art. 14d to 14h of the Volksschulgesetz VSG. They clarify and supplement the following legal framework conditions: Regulations on Education of the Niederbipp Municipality (1.12.51) and the Day School Ordinance of the Niederbipp Municipality (1.12.170).

The parents'/guardians' agreement to the day school regulations is a prerequisite for a childcare agreement with the Niederbipp municipality. These day school regulations apply to the Niederbipp day school.

Care services and tariffs

Various childcare modules are available. Childcare is provided during school hours, with the exception of teacher training days and holiday bridges, including November breaks.

There is a charge for childcare. The parental contribution for childcare depends on income and is set by the canton between a minimum and a maximum amount (Fr. 0.79 - Fr. 12.35 as of 1.8.2021). The costs for meals (breakfast Fr. 2.-, lunch Fr. 8.-, snack Fr. 2.-) and care are invoiced quarterly / monthly.

The parents/guardians acknowledge that the municipality of Niederbipp will inspect the tax data in order to determine the rate for the hours of childcare. If desired, the municipality can waive the inspection, in which case the maximum tariff is applied.

Registration

Registration is done in paper form or via the kiBon platform, including income declaration, up to one week after the timetable is submitted. Registration is binding for the entire school year. Late registrations will be charged a fee of Fr. 75.

Each child is registered for at least one compulsory module.

Module 1 and 2 can only be booked together on Wednesday and Friday afternoons.

Lesson times in afternoon module 1 will not be charged.

An increase in the originally registered childcare hours must be approved by the day school management. A reduction of the originally registered childcare hours during the school year is not possible.

Subsequent registrations

Subsequent registrations for new residents and children of young professionals can be booked in consultation with the day school management (without a fee).

Subsequent registrations for other reasons can be booked in consultation and according to possibilities. (There is a fee of Fr. 75.-)

Termination of care

Cancellation of childcare is possible as of 31.1. The written notice of termination must be received on the last school day before the Christmas holidays.

Exception: moving away: notice of one month to the end of the month. In case of early departure, the fee for the whole month is due.

Allocation of costs

Registered modules, breakfast and snack will be charged even if the child is absent. Lunch will not be charged if the child deregisters before 09:00.

Country school weeks, teacher training days and bridge days are not charged.

In case of longer absences (longer than one week) due to illness or accident of the child (doctor's certificate), the fees will be reduced in proportion to the absence.

Final provisions

Parents/guardians with a valid childcare agreement will be informed in good time in writing of any changes to the day school regulations, taking into account the period of notice. If the childcare agreement is not terminated within this period, the amendments to the Day School Regulations are deemed to have been accepted.

These day school regulations will come into force for the school year 2019/20 (from 1 August 2019).
